The meeting commenced after an Open Session for Chilthorne Domer Parishioners only, with no members of the public present there were no items raised.

#### AGENDA ITEMS

- 139. APOLOGIES FOR ABSENCE** – Apologies were received from Mr Preston, Mr Batstone and Cllr Williams.
- 140. DECLARATIONS OF INTEREST** – None received.
- 141. MINUTES OF THE PREVIOUS MEETING** – The minutes of the previous meeting were unanimously agreed as a true and accurate record.
- 142. COUNTY COUNCILLOR'S REPORT** – Cllr Williams had previously circulated his report via email.
- 143. DISTRICT COUNCILLOR'S REPORT** – Cllr Roundell Greene gave her report to the meeting. SSDC's budget was passed at the full council meeting recently and in financial terms SSDC seems reasonably healthy, recent changes made mean that services haven't had to be cut. Cllr Roundell Greene has received a report from SCC which shows that the Sports and Youth project in Chilthorne Domer has been cut with Tintinhull also having been affected. Cllr Roundell Greene suggested that a combined effort between the two parishes may prove useful. Following discussion Mrs Ferguson agreed to attend the next recreation area trust meeting to enquire about the youth club and what the current level of interest might be. Cllr Roundell Greene also reported that SSDC's new website is online and teething problems are being addressed.
- 144. COMMUNITY SAFETY & POLICE MATTERS** – There has been a further response to the Speedwatch advert, it was agreed that the advert is to be republished in the newsletter, with the wording changed to clarify the area of greatest concern – Tintinhull Road near the school. Following discussion it was agreed that the clerk is to enquire about the current status of the Small Improvement Schemes.
