COUNTY COUNCILLOR'S REPORT Cllr Williams gave his report to the meeting which included details of the changing regulations regarding the current Covid-19 pandemic and the increasing rate nationwide. Cllr Williams also updated the meeting on the status of the two Small Improvement Schemes, the work orders for which have been submitted. Cllr Williams informed the meeting that Somerset County Council would be unable to fund the maintenance of the fingerpost sign mentioned at the last meeting as it is not considered essential, they have produced a booklet regarding the requirements for contractors which Cllr Williams would be happy to provide to the Council. Cllr Williams detailed the efforts being made by himself alongside Cllr Bloomfield regarding the reduction of the speed limit on Tintinhull Road.

- a) Applications: 20/02047/OUT, Land South of Tintinhull Road, Chilthorne Domer, Somerset. Outline application for residential development for up to 73 dwellings, including access with all other matters reserved. It was explained that although the application site is within Brympton Parish Chilthorne Domer Parish Council were being consulted as a neighbouring authority. The application was discussed at some length with various issues being raised including infrastructure improvements; possibility of a change in Parish boundary to include these dwellings as part of Chilthorne Domer Parish; the application seems to be being considered as a separate entity and should be considered alongside the other development nearby. Mr Brandt offered to pull the comments together into a document to be share amongst the Council prior to the meeting next week which can then be considered when a decision can be made.

- **11. ALLOTMENTS** Mr Scott reported that the plan is to launch the new shared allotments from January, the forms have been drafted and the intention is to use the website for people to sign up.
- 12. VILLAGE HALL Mr Brandt reported that the Village Hall has re-opened for use by the school 4 days a week for extended mornings or afternoons although this is causing some issues with other users not being able to use the Hall due to the cleaning requirements to ensure the Hall is Covid-19 safe. Negotiations are taking place with other users to allow them to use the Hall at other times. Mr Brandt asked on the progress of the broadband installation and was informed that it hadn't been taken forward at this point.
- 13. RECREATION TRUST Mr Tasker reported that the Trust had held their AGM last week in which it was reported that the finances were healthy thanks to the Government grant due to Covid-19, but the income has evaporated and ongoing expenses continue. The refurbishment of the bar area project is ongoing and Ash football club have re-started their training sessions. Mr Tasker also informed the meeting that the safety checks on the play equipment had taken place. The bar is currently open on Thursday and Sunday evenings.
